

### What does it mean to be accredited?

#### Accreditation allows NGOs to participate in UN proceedings by:

- Attending UN Forums, conferences, commissions, briefings,
- Making oral statements
- Submitting written statements
- Sponsoring events inside and near UN Headquarters
- Meeting with diplomats
- Making formal or informal recommendations on new UN declarations and resolutions as they are being negotiated
- Submitting reports and comments to national review processes (e.g. CEDAW, Voluntary National Reviews on SDGs,

Universal Periodic Review at Human Rights Council)

# What is the role of NGOs in the UN System?

 Raise issues that are of concern to us at local and national level. Feed-back from members working on the ground is essential for this.

Shape decisions through input to UN processes.

 Hold our national governments and the UN accountable. With partners on the ground we observe, critique, report and offer alternatives.

# Religious Presence among NGOs at the UN

- Over 30 NGOs collectively represent over 200 congregations of Catholic women and men Religious
- Bring credibility by providing insights from members' work ministering to the poorest and most vulnerable populations "on the ground"
- Bring impartiality as most are present in many nations and have no national identity
- Bring moral voice as faith-based groups known for a life of dedication to human dignity of all and care of the natural environment

# Role and Responsibilities of IBVM/CJ NGO Representatives

- Promote and raise awareness of the IBVM/CJ network about United Nations and key issues on its agenda especially those relating to women and girls
- Promote and raise awareness of the IBVM/CJ network about Human Rights and Sustainable Development Goals (SDGs 2030)
- Advocate at a global level for the concerns and issues of the communities where IBVM/CJ are present
- In collaboration with IBVM/CJ network provide the UN with information and analysis on issues as required based on their experience on the ground
- Assist in monitoring and implementing UN Conventions, Declarations and International agreements in member countries in collaboration with IBVM/CJ network
- Provide opportunities for IBVM/CJ network to attend UN Commissions and Forums international conferences by informing and preparing them for applicable events
- Provide opportunities for immersion and internship with IBVMUNNGO in New York

#### **How the NGO Functions**

As an NGO in consultative status with ECOSOC we contribute to UN processes Commissions and Forums in the following ways through:

- International Network engagement

- Input into processes (e.g. preparation of documents for Forums, Commissions)
- Side- Events, led by our NGO and others which we co-sponsor.
- Collaboration with NGO Committees, Working Groups and Major Groups.
